# Horizon 2020 is the biggest EU Research and Innovation programme with nearly €80 billion of funding available over 7 years (2014 – 2020)

### HORIZON 2020

Horizon 2020 is the world's largest multinational programme for supporting research and innovation. It is the European Union's flagship research funding programme and is fully open to researchers from public and private organisations from across the world.

#### Together we can:

- Extend the frontiers of scientific knowledge
- Tackle challenges that affect us all wherever we are such as infectious diseases, energy security, food safety and climate change
- Make industry, and notably SMEs, more competitive by linking research firmly to innovation, leading to better products and services for us all

## EU – South Mediterranean R&I cooperation in FP7 (2007-2013)


#### **296 FP7 funded** projects

- Success rate 13%
- 704 million EUR EU contribution to the projects

- **586** participations of public and private South Mediterranean institutions

### Marie Skłodowska-Curie actions (MSCA)

From January 2014, the Marie Curie Actions will be renamed the Marie Skłodowska-Curie actions (MSCA). They come under the "Excellent Science" pillar of Horizon 2020.



- ✓ Significant EU fellowship programmes since 1990 (FP3) for researchers' mobility
- ✓ Marie Curie label since 1996
- ✓ Actions aimed at structuring training, mobility and career development for researchers

### **MSCA Objective**

#### Main objective

Ensure the optimum development and dynamic use of Europe's intellectual capital in order to generate new skills and innovation

#### Rationale

- ✓ Encourage new, creative types of training
- ✓ Identify excellent talents in research and innovation in international competition
- ✓ Make best researchers in Europe and the world work together across countries, sectors and disciplines
- ✓ Create a whole new mind-set in Europe, crucial for entrepreneurship and innovation

How does it work?	Proposal submitted by researcher in liaison with host. Successful proposals receive up to 2 years' support (additional 1-year return phase in Global fellowships). ### Individual fellowships (IF):

Who
The best, most promising individual researchers from anywhere in the world are encouraged to apply. Fellowships are for experienced researchers. (Min 4 Years Experience)

To apply you must submit a research proposal, including your CV, in response to the call for proposals. The proposal is written jointly with your chosen host organization(s) (a university, a research center or a company).

#### Which topics can be funded?

Any research field may qualify for IF funding, apart from research areas covered by the EURATOM Treaty.

#### What does the funding cover?

The grant is awarded to your host organisation in Europe. The grant provides an allowance to cover your living, travel and family costs. The research costs and indirect costs of the host(s) are also supported.

Successful proposals (selected through open competition, independent peer review, using a series of predetermined criteria) are typically funded for one to two years.

In the case of a Global Fellowship, an additional twelve-month return phase to Europe is also financed.

### Individual fellowships (IF):

#### **There are two types of Individual Fellowships:**

#### **European Fellowships**

- » Held in EU Member States or Associated Countries
- » Open to researchers either coming to Europe or moving within Europe
- » Researcher funding is for one to two years
- » Can help you restart your research career after a break such as parental leave
- » Can help your reintegration if you are coming back to Europe

(Marie Curie Fellow: Nadine Zeeni, Lebanese American University, Lebanon; FP6)

#### **Global Fellowships**

- » Fund secondments outside Europe for researchers based in the EU or Associated Countries
- » Researcher funding is for two to three years
- » There is a mandatory one-year return period

# KNOWLEDGE SHARING ACROSS SECTORS AND BORDERS RESEARCH AND INNOVATION STAFF EXCHANGE (RISE)

RISE will support short-term mobility of research and innovation staff at all career levels, from the most junior (post-graduate) to the most senior (management), including also administrative and technical staff. It will be open to partnerships of universities, research institutions, and non-academic organizations both within and beyond Europe. In worldwide partnerships, academia-to-academia exchanges will be permitted.



#### **Priority 2. Industrial leadership**

Strategic investments in key technologies (e.g. advanced manufacturing, micro-electronics) underpin innovation across existing and emerging sectors

Need for more innovative SMEs to create growth and jobs

### Leadership in enabling and industrial technologies (LEITs)

#### Access to risk finance

### A Dual Approach to International Cooperation

Openness: Horizon 2020 open to participation from across the world, meaning that (except where this is explicitly excluded) European researchers can cooperate with their counterparts in third countries on any topic of their choice. (Increased Competition!!!)

Targeted actions: (Projects which required or give preference to 3rd country participation; developed on the basis of <u>common</u> interest and <u>mutual benefit</u>)

- Thematic: identifying areas for international cooperation on the basis of the Union's policy agenda
- Differentiation by countries/regions to target partners for cooperation

### **International Cooperation**

Openness: Horizon 2020 open to participation from across the world, meaning that (except where this is explicitly excluded) European researchers can cooperate with their counterparts in third countries on any topic of their choice.

### Regional Participation in Horizon 2020

As a general rule, the legal entities and individuals established in the ENP countries may participate in all parts of the programme (exception: access to risk finance)

The minimum rules of participation should be observed:

- For standard collaborative actions: At least three legal entities each established in a different Member State or an Associated Country
- For ERC, SME instrument, programme co-fund, coordination and support, training and mobility actions: One legal entity established in a Member State or in an Associated Country

Additional conditions can be set out in the work programme; e.g. number of participants, type of participants etc.





#### How to participate

H2020 ONLINE MANUAL

The first steps to prepare your proposal and apply for EU research funding. Learn how to find a suitable Call for proposals or project partners and how to submit your proposal.

The following guidance services facilitate your participation:

- H2020 Online Manual: step-by-step online guide through the Portal processes from proposal preparation and submission to reporting on your on-going project
- Reference documents: library of legal documents, guidance notes, and additional reference material for H2020 and FP7



### 1<sup>st</sup> Call - Statistics

Out of a total of 190 submitted proposals, 20 Eligible Proposals were submitted by Lebanese Researchers: AUB (6 Proposal), CNRS-L (7 Proposal), USJ (2 Proposal), UoB (1 Proposal), BAU (2 Proposals), NDU (2 Proposals), USEK (2 Proposals), LU (2 Proposals) & LAU (1 Proposal).

21 proposals passed all phases of the evaluation and funding agency selection of which 3 Projects, with a Lebanese Partner, were co-funded by the CNRS-L


### Challenges in the Region

 Working in important societal challenges in the Mediterranean region and face common constraints and issues

- Trans-national research addressed to these challenges is still highly fragmented and requires a strong co-ordination and joint-effort of countries to enhance effective and high impact research as well as innovation.

### What will be funded?

The following actions will be eligible for funding

#### a) Collaborative research

Should take into account to develop an impact, demand and policy driven research, also accounting the inclusion of SMEs and enhancing innovation.

#### b) Innovation

Including prototype development and demonstration actions.

#### c) Capacity building

Including also support to build capacity for enhancing innovation

#### d) Mobility

Mainly based on supporting grants to young researchers from MPCs to develop postgraduate studies linked with funded projects

- ✓ All projects <u>must</u> be collaborative research projects (action a.)
- ✓ Applicants are encouraged to propose collaborative projects including at least another of the above actions (b,c,d), provided that the national funder covers such action

### **How to Apply**

#### **STEP 1: ERANEMED CRITERIA (Call Secretariat)**

- ➤ Applicants from research and higher education entities, companies, and other legal entities such as NGOs.
- ➤ 3 Partners (1 from EU, 1 from MPC) from separate countries participating in the Call
- Be of a duration comprised between 24 and 36 months;
- Other applicants may apply but fund their own participation
- The duration of a project can range between 24 and 36 months.
- Proposals shall address only one of the 3 themes

Lebanon Alone (Not Eligible)
Lebanon / Egypt / Jordan (Not Eligible)
Lebanon / Egypt / France (Eligible)

Lebanon / Egypt / France / Italy / Jordan (Eligible)

### **How to Apply**

#### **STEP 2: National Criteria (CNRS-L)**

- ➤ At least One (up to 3) Lebanese Partner Institution.
- ➤ Each researcher can participate in more that 1 Project, but can be the main investigator in only one project
- Key Researchers included (By Institution, name and position) and/or scientific expertise
- Submitted by Full-Time Staff through their institutions


#### **Funding Criteria**

- Total CNRS Contribution: 200,000 Euros
- Three to Five Projects can be funded
- CNRS contribution for each project cannot exceed 50%
- All Participating Institutions will Cost-Share in any submitted proposal
  - ✓ Letter of Commitment (from the Institutions involved)

# Evaluation of the Proposals will be undertaken by an External Advisory Board

Following the Results of the Evaluation; Projects are funded based on an external ranking and budget availability (Lebanese + Other)




